PROFIT WARNING ESTIMATED REDUCTION IN LOSS

This announcement is made by New World Department Store China Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company and potential investors that, based on a preliminary assessment on the unaudited consolidated management accounts of the Company for the year ended 30 June 2021, the Group expects to record a loss attributable to shareholders of the Company of approximately HK\$230.0 million for the year ended 30 June 2021, as compared to a loss attributable to shareholders of the Company of approximately HK\$483.7 million for the year ended 30 June 2020.

The estimated reduction in loss for the year ended 30 June 2021 is primarily attributable to (i) a decrease in impairment loss on assets, including goodwill and loss in fair value of investment properties recognised for the year, as compared with the year ended 30 June 2020; (ii) a decrease in operating expenses for the year compared with the year ended 30 June 2020; and (iii) an increase in net exchange gain mainly arising from the changes on Hong Kong dollar against Renminbi.

The information contained in this announcement is only based on the preliminary assessment by the Board in accordance with the unaudited consolidated management accounts of the Company for the year ended 30 June 2021, and is not based on any information or figures which have been audited or reviewed by the Company’s auditors and may be subject to possible adjustments. Shareholders of the Company and potential investors are advised to read carefully the annual results announcement of the Company for the year ended 30 June 2021 which is expected to be published in September 2021.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
